4.3 **Ordinary Members** are members aged 18 years or over on the 1st of April in the subscription year.

4.4 **Junior Members** shall be aged 12 years to 17 years on 1st April in the subscriptions year. They shall not be entitled to use the Club equipment or facilities unless under the direction/coaching of an appropriate Member of the Club. Junior members shall have no voting rights and will not be allowed to attend meetings of the Club.

4.5 **Life Members** are Ordinary Members who have paid 25 consecutive annual subscriptions, excluding Associate. To qualify for this category the member must have joined the Club before 1st April 2018.

4.6 **Country Members** shall be those Ordinary Members who have paid at least one Ordinary Subscription, who ordinarily reside outwith 40 miles distance from the Clubhouse by the most practical means of transport, and do not reside locally for more than one month during the boating season.

4.7 **Clubhouse Members** shall be at least 21 years of age on admission. They shall not be entitled to use the Club boats nor keep a boat on the foreshore or in the Club premises or take part in watersports activities at the Club but shall be entitled to wear the Club uniform.

4.8 **Honorary Members** may for special reasons be elected at any General Meeting of the Club, but shall have no voice in the management of the Club.

4.9 **Honorary Life Members** are those Life Members who were elected before 28th February 1973 and elect not to pay the Life Membership Subscription and who request in writing to the Committee that they shall be elected as an Honorary Life Member. They will be allowed to attend meetings of the Club and deliberate but will not be allowed to vote or be elected to the Committee.

4.10 **Family Members** are members of the same family: spouses, civil partners and cohabitants aged 18 years or over on the 1st of April in the subscription year, their children and / or children for whom they are legally responsible up to the age of 17. Adults shall be Ordinary, Life, Student or Country Members and shall be entitled to take part in the management of the Club. All those under age 18 must be under appropriate adult or family supervision at all times. The Subscription for this category shall be equivalent to the sum of the Subscriptions due by the individual adult or adults declared as being in family group.

4.11 **Student Members** are Members who are aged 18 to 25 years on the 1st of April in the subscription year. They must be in full time education or training.
