⁵ Country members shall be those ordinary members who have paid at least one ordinary subscription, and who reside outwith a distance of 40 miles from the club house by the most practical means of transport, and who do not reside locally for more than one month during the boating season (April to October).

⁶ Associate members shall be at least 21 years of age on admission; shall not be entitled to use the Club boats nor keep a boat on the foreshore or in the Club premises.
